Eleven of us met Thursday, 8/17, to fine-tune our message and approach on planning for deliberative dialogues about affordable housing.

1. What

We agreed to collectively edit the attached revised message that SDDN members would use in approaching a few *Idea Generators*. Please use "Track Changes" and copy "all" when sending copies of your revisions. Or, if it's easier, just send your ideas to me and I will compile them with attribution.

Comments:

- The revised message will describe the concept of community deliberation forums, but not specifically target Community Planning Groups, allowing the scope to broadly cover San Diego County.
- Idea Generators should be encouraged to comment on the specifics of the framing question and any or all the 4 points of view we've identified.
- Martha's questioned doing an advanced survey of the community to capture the "voice of the people,"
 a typical preliminary step in preparing an issue for deliberation. Hank felt we would likely do a survey in
 the fullness of time before actual forums begin.

2. Who should we approach to propose ideas?
