Nine of us met Thursday, 7/20, on how we can prepare for deliberative dialogues about affordable housing.

1. What

We agreed on the framing statement: **How can the San Diego region bring the amount of family income spent on housing closer to 30% in the next 10-30 years?**

Comments:

- Some discussion that the actual percentage doesn't matter but serves as a starting place
- Some kind of metric is useful for comparison across various proposals
- Proposals might be grouped around 4 points of view:
 - o Build, Build, Build
 - o Smart Growth
 - o Government Subsidies for housing
 - o Slow Growth

2. Who should we approach to propose ideas?

Comments:

- To make proposals comparable, all should address impacts on infrastructure, transportation, economic vitality, etc.

Points of View	Considerations	Who Could Represent this Point of View?
Build, Build, Build	Infrastructure? Transportation? Funding?	Faulconer Plan Building Industry Association
Smart Growth	Transportation, Affordability, Supply-side approach	Academia, Planners, Urban Land Institute
Government Subsidies for housing	Funding? Public-private partnerships, low-income considerations	SDOP, CPI, Alliance San Diego, Toni Atkins' proposal
Slow Growth, Neighborhood Preservation, Age-friendly	Local control vs. common good	Environmentalists, Minimalists, Preservationists (Harder to find cohesive representation & coherent proposals)

3. How should we 1) convince groups to make proposals and 2) attract deliberation participants/venues?

We agreed we need to draft a letter describing our vision and pursue both constituents simultaneously.



Comments:

- Our draft will describe SDDN’s background, affiliations, training and mission of promoting deliberative democracy.
- Our approach will describe SDDN as *passionately impartial*, offering benefits to all stakeholders.

Stakeholder	Beneficial Outcome
Idea Generators	Good ideas get heard and deliberated by a wider field
Decision Makers	Changes the conversation, different from what’s gone before. Builds civility and community engagement.
The community	Allows members to hold themselves accountable for their ideas.
